注: 1. 此表为按照国际货币基金组织数据公布特殊标准 (SDDS) 要求发布的月度中央政府收支及融资数据和季度中央政府债务余额。

2. 按照国际货币基金组织颁布的《政府财政统计手册》的口径, 政府财政收入包括税收、社会保障缴款、赠与和其他收入 (其他收入主要指财产收入、出售商品和服务收入、罚金罚款和罚没收入以及其他杂项收入)。据此计算, 本表中中央政府收入, 是指一般公共预算收入、政府性基金收入 (不含国有土地使用权出让收入)、国有资本经营收入的合并数据, 并剔除了重复计算部分。不包括国有土地使用权出让收入, 是因为根据国际货币基金组织《政府财政统计手册》的定义, 政府收入是指增加政府权益或净值的交易, 国有土地出让行为是一种非生产性资产的交易, 结果只是政府土地资产的减少和货币资金的增加, 并不带来政府净资产的变化, 不增加政府的权益, 因而不计入政府收入。相应地, 中央政府支出也按上述口径统计。

3. 本表中央政府融资不包括用于国债还本的融资。

Note: 1. This table provides central government operations and debt data, which is the monthly central government operations and quarterly central government debt in accordance with requirements of IMF's Special Data Dissemination Standard.

2. The central government revenue data in the above table represents the consolidated operations of the general public budget, the government-managed funds budget (excluding the revenues from the sale of state-owned land-use rights), and the state capital operation budget. Consolidation entails eliminating any transfer payments among the three budgets. Similarly, the expenditure data apply the same method.

3. The central government financing data in the above table do not include the payment for the principal of national debt.
